

I Ghanashyam Karmakar, s/o Dhirendranath Karmakar (died), resident of Vill.-Bartar, Panchayat.- Baragram, PS.- Joypur, Dist.- Purulia (WB). I beg to inform you that on dt. 21/10/2020, around 6-6:30pm, at Bartar Haat NH-32 Road, there was a road accident in which my father Dhirendranath Karmakar was injured badly. He is no longer alive.

Vijay Dubey, resident of Vill- Rudra was/is the person who made/did the accident. with his bike super splendor (Reg. No. JH11J/6015). He was riding with alcohal. And this incident was informed to Joypur Police.

My injured fathe was treated respectively again in Sadar Hospital Purulia, then in KMM hospital Chas, Bokaro (JH) and then finally in BNM hospital Tamolia, Seraikela Kharsawan (JH)

My injured father's condition was critical. He was conscious but his entire body was numb and swollen. Due to damage of spinal cord there was no movement and feelings in the body. The doctor suggested to operate the spinal cord but there was no chance for success the operation and recovering the patient and also no guarantee for his life. The ricks will be continue. We got his spinal cord operated but still he did not survive more than a week after the operation.

On 18-11-2020, around 7:00am, the doctor/BNMH declared him dead.We spent a lot of money in his treatment but still we could not save him.

After that on the orders or request of Joypur Police, the medical superintendent of BNM Hospital handed over the corpse to the Kapali police for the post-mortem. The Kapali Police investigated and registered the statement of my mamaji/m-uncle "Manoj Vishwakarma" and proceeded for the process of post-mortem. And finally the post-mortem of his body was held on 19/11/2020 at 1:00 pm in MGM Medical College & Hospital, Jamshedpur.

On that day around 5-5:30pm my mamaji/m-uncle reached with my father's dead body in our native place at Bartar(PS Joypur) where we duly cremated him. Sir,, Vijay Dubey made us an orphan and my mother a widow. I urge you to file a case against him that he should be punished severely and hope that we get justice. Sir, a person who drives fast in a crowded area with drinking alcohol that kills someone and does not take care of him/her and his/her family should be punished
