Sir.

In producing here with the accused persons namely (1) Pratap Chowdhury (21 yrs) S/o-Gobinda Chowdhury (2) Chunna Bhuniya (22 yts) S/o-Late Nur Bhuniya both of Jiudaru PS-Kotshila Dist-Purulia brought under arrest along with seized articles as per seizure list i.e. one improvised country made one shooter Iron made pipe gun length approx 10 inches having Iron butt, body, barrel, trigger, firing pin etc and one round live ammunition loaded was found from Pratap Chowdhury with his left side waist & one round live ammunition found from Chunna Bhuniya which was kept in his left side pant pocket, I, ASI Ananta Kr De of Joypur PS do hereby lodged a written complaint against the above noted accused persons to the effect that on 14/02/2021 at 21:05 hrs, duty officer of Joypur PS, SI Prabir Kr Dey received a secret source information that two persons were moving on Joypur-Pundag pitch road near Sashi more under Joypur PS in suspicious manner. After receiving such information duty officers noted the fact in GD vide Joypur PS GDE No-680 dated-14/02/2021 and after discussion with IC Joypur PS inform me to work out the information. As such myself along with force C/-2087 Debasish Ghorai JC/-1515 Md. Manjur Ansary immediately left to work out the information vide Joypur PS CC No-679/21 dated 14/02/2021 and on 14/02/2021 at 21:35 hrs we reached near to Sashi more and keeping our Govt. Vehicle No-JH20A-7580 in a safe distance we slowly moved to the information place and found said two persons were standing under a tree nearby for any crime upon the ongoing vehicle on Joypur-Pundag pitch road at any time and we able to apprehended them and on being suspicion. I search the said persons and found that one improvised country made one shooter Iron made pipe gun length approx 10 inches having Iron butt, body, barrel, trigger, firing pin etc and one round live ammunition loaded was found from Samial Biswas with his left side waist in his full pant & one round live ammunition found from Jatan Biswas which was kept in his left side full pant pocket. On demand of papers they failed to produce any papers / documents in support of carrying / possessing such fire arms. On interrogation they disclosed their identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arms and ammunition. It is reasonable to believe that they choose the said place pre-plainly to commit any grievous offence against vehicle. So finding no other alternative and after observing all the formalities I seized the said fire arms and ammunition under a proper seizure list in presence of witnesses as well as accused person in between 22:35 hrs to 22:55 hrs and make over one copy of the seizure list to them and they put their signature as taken of acknowledgement and also labeled the same by me. I tried my label best to singe the public witnesses but as time is in night and the place is far away from villages. So none is available there, So I unable to put signature any public witnesses on the seizure list. Hence I arrested them in between 23:05 hrs to 23:15 hrs after issuing memo of arrest as they is liable for prosecution u/s 25 (1) (a) Arms Act.

I therefore pray that a specific case may kindly be started against the accused persons namely (1) Pratap Chowdhury (21 yrs) S/o-Gobinda Chowdhury (2) Chunna Bhuniya (22 yrs) S/o-Late Nur Bhuniya both of Jiudaru PS-Kotshila Dist-Purulia under proper section of law and arrange its regular investigation.
