Sir,

In producing here with the accused person Shaktilal Mandi (19 Yrs) S/O Bijay Mandi of Bhutpara, Parasole, P.S – Kashipur, Dist Purulia, brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arms (Iron made) length in total 10 Inch (Approx) having wooden butt, body, barrel, trigger, firing pin etc and 01 (One) round live ammunition, I SI Arun Maji of Kashipur PS do hereby lodged a written complaint against the above noted accused person to the effect that today on 14.02.2021 at 19.45 hrs while myself along with JC/1450 Sushil Kr Majhi, NVF/693 Jayanta Singh Sardar, (Kashipur PS CC No – 396/21 dated - 14.02.2021) all of Kashipur P.S were engaged in evening mobile cum Naka checking duty at Gamarkuri More on Kashipur – Hura metal Road and found the above noted person was coming from Kashipur Side via Kashipur – Hura metal Road towards Hura by foot and on seeing the Naka Checking party he tried to fled away. Immediately my team chased him and apprehended him near Gamarkuri More. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arm loaded with one round live ammunition was kept in his left side of the waist concealed under the jacket. On asked he disclosed his identity as Shaktilal Mandi (19 Yrs) S/O Bijay Mandi of Bhutpara, Panrasole, P.S – Kashipur, Dist Purulia. On demand he was unable to produce any valid documents / license in respect of keeping such arms & ammunition, neither he can gave any satisfactory explanation in respect of carrying such arms ammunition. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammunition with proper seizure list and the seized arms and ammunition packed, sealed and leveled in presence of police witnesses since none found there available to witness. The seizure in between 20:05 hrs and 20:25 hrs. Hence I arrested him at 20:35 hrs as he has committed an offence which is punishable under Arms Act.

Hence I pray to start specific case against accused Shaktilal Mandi (19 Yrs) S/O, Bijay Mandi of Bhutpara, Panrasole, P.S – Kashipur, Dist Purulia u/s Arms Act and for its investigation.
