Sir,

In producing herewith one tractor attached with trolley without number plate, having Engine.No. E3583629 and Chasis No. T053518984JJ loaded with stone about 100 CFT along with Seizure List. I beg to state that today on 07/02/2021 I along with C/2567 Bubun Mahanty and NVF-826 Ramcharan Mahata performing mobile duty vide Kenda PS C.C. No. 168/21 dtd. 07/02/2021 and GDE No. 197 dtd. 07/02/2021 with Govt. Vehicle bearing Reg. No. WB42S-1504. I was carrying normal investigation kit box with me.

During Mobile Duty at Rajnowagarh more at about 12.15 hrs. received source information about extracting and transportation of stone with intend to sale to other destinations by illegal means from Kamta side towards Kenda under this PS jurisdiction.

I conveyed the same to O.C Kenda PS and as per his direction I along with force started Naka Checking at Kesya More from 12.35 hrs. At about 12.55 hrs. one tractor without number plate having Engine No. E3583629, and Chasis No. T053518984JJ loaded with stone was coming towards the Naka Point and seeing the police party the driver fled away after keeping the tractor beside the road at Kesya More. Chases him but somehow he managed to escape. Seized the tractor attached with trolley loaded with stone about 100 Cft.

Held an enquiry about the matter and so far information collected, it is crystal clear that the driver and the owner collected the stone by illegal means with intend to make unlawful profit by unlawful collection of stone by illegal manner through unauthorized extraction and removal of Mines & Minerals. By this way they committed theft of minerals.

Under the above facts and circumstances, I pray before you that kindly take needful action against the owner and driver of the said tractor.
