Sir,

In producing herewith seized vehicles (Tractors) bearing Registration No. WB55B-0627 attached with Trolley loaded with sand approx. 100 Cft. along with Seizure List. I beg to state that today on 07/02/21 myself along with C/1182 Santosh Mahata and C/1492 Dilip Ch. Gorain all of Kenda PS were performing evening mobile duty vide C.C. No. 170/21 dtd. 07/02/21 and GDE No. 209 dtd. 07/02/21 with Govt. vehicle bearing Registration No. WB42S-1504.

During mobile duty at about 19.45 hrs. when we reached at Lepodi More found that the above noted tractor was coming from Darodih side on Purulia-Manbazar road towards Lepodih More. On seeing the Police party the driver of the said tractor stopped the tractor in a distance and fled away after keeping the tractor beside Lepodih More. Chased him but somehow he managed to escape. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Reg. No. WB55B-0627 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the tractor at Kenda PS. So it reason to belief that they procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Registration No. WB55B-0627 attached with Trolley loaded with sand.
