



BRIEF DESCRIPTION OF THE FACT AND CIRCUMSTANCES :

- 1. That, the fact in nut shell of the offence is that
 Parties are Hindu by Religion and Governed by Hindu
 Law and relevant Section imposed upon them under
 Indian Penal Code.
- 2. That, marrige of Parties following negotiation with Mediation was solemnized on 18th Jaistha, Friday (02-06-2006) observation all ritual/customs prevailing for solemnization of marriage social marriage. Before





solemnization of marriage father of Complainant had given cash of Rs. 50,000/- (Rupees Fifty Thousand) and the rest 20,000/- (Rupees Twenty Thousand) will be paid within one year, and brass metal Utensils, Five Bharies Golden ornaments, 10 Bhories Silver ornaments and other Furnitures and clothes and satisfied members of matrimonial family in all respect by the gifting as par their demand.

- That, on the next date of marriage after observing all customs and ritual of "Bidai" in the house of father Complainant started a new journey and reached accompanied by her husband at residential house of Father-in-law of village Kotshila, P.S. Kotshila, District Purulia.and every heartily and delightfully welcomed and accepted by all members relatives in matrimonial house.
- 4. That, Complainant was leading a happy peaceful marriage life and pleasing her parent in matrimonial house by her conduct and behaviour as well as providing all service according to her ability and matrimonial alliance/relationship was good and Complainant and her husband used to visit frequently in her father's house at Village Satra andby this time both of them was blessed with three children and after few days environment surrounding situation and behaviour towards complainant started changing and she was often insulted with rough and filthy language and blammed.



- 5. That, on 05-12-2020 and this time she was subjected to physical torture in them hand of the husband and other accused persons by kick and blow and therefater forcibly send her to her father house to bring rest dowry amount of Rs. 20,000/- for the purpose of vehicle business and further told bring the money positively otherwise she would not be allowed to stay and fact with dire-consequences and then they got Rs. 20,000/- and allowed to stay in matrimonial house.
- E. That, on 05-12-2020 in the night Complainant forcibly confined in a room with closed door from outside and withdrawn x from all foods alongwith systematic torture physical assault and one day all the accused persons making pre-plan in mind with an intend to finish her life by giving poison in the food by beighbourers by breaking closed doors and send her to her father house for treatment of taking poison.
- 7. That, after such incident father of Complainant tried to his best along with other franciscincing tried their best for reconciliation and went repeartedly before matrimonial house and requested to allow him for taking to her datuther but yield no good result rather relationship and alliance fallen into a baggers drain and they wanted to put the relationship to end, and Rahul Kumar(husband) married second time with Kuleshwari Kumar after this incident.





information of Complainant nor send any money for food and on the basis of the Complainant lodged by the Complainant before Kotshila Police Station, but no action was taken. Thereafter Complainant lodged complain before the Superintendent of Police, Purulia on 28-12-2020 alleging all matters with prayer to issue direction to registered specific case and no case started by Kotshila Police Station the reason known best to him.
