Sir,

In producing here with one accused person Montu Sahish (42) S/O Lt Bhim Sahish of Village - Chirudih PS- Manbazar District Purulia along with following seized articles viz-

- (1) 18 (18 ~~litres~~) Ltrs ID liquor within a Jarikan
- (2) 03 pieces plastic glass

I S.I Indrajit Sarkar of Manbazar PS do hereby lodged a complaint against accused namely Montu Sahish (42) S/O Lt Bhim Sahish of Village - Chirudih PS- Manbazar District Purulia in the effect that today (01.02.2021) at 18:35 hrs, I received a telephonic information from a reliable source that one Montu Sahish (42) S/O Lt Bhim Sahish of Village - Chirudih PS- Manbazar District Purulia has stocked ID liquor illegally and selling the same after hike price for his personal gain. I noted this information in CDE vide Manbazar PS GDE No-32 Dtd 01.02.2021. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1119 Susanta Singha, NVE/566 Tapas Mahato both of Manbazar PS District Purulia rushed to the spot for conducting raid by Govt. vehicle. At about 19:05 hrs myself along with force reached at Chirudih village more and held raid of Montu Sahish and found that said person selling ID liquor. Seeing the Police party some persons fled away and said Montu Sahish tried to concealed himself but he was able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Montu Sahish (42) S/O Lt Bhim Sahish of Village - Chirudih PS- Manbazar District Purulia as per law and arrange for its investigation.
