Sir,

In producing here with one accused person Sanjoy Kumar Chowdhury (35) S/O Chandu Chowdhury of village Bonkata PS Manbazar District Purulia along with following seized articles viz-

- 1) 15 (Fifteen) Ltrs ID liquor within a Jarikane
- 2) 04 pieces plastic glass
- 3) 200 ML ID liquor collect from the Jarikane as sample

I S.I. Aniruddha Chatterjee of Manbazar PS do here by lodged a complaint against accused namely Sanjoy Kumar Chowdhury (35) S/O Chandu Chowdhury of village Bonkata PS Manbazar District Purulia to the effect that today (01.02.2021) at 19:45 hrs. I received a telephonic information from a reliable source that one Sanjoy Kumar Chowdhury (35) S/O Chandu Chowdhury of village Bonkata PS Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 33 Dtd 0102.2021. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/441 Santo Das & C/1316 Ujjwal Mandal rushed to the spot for raid by Govt. vehicle. At about 20:15 hrs. myself along with force reached at Bonkata village and held raid in the house of Sanjoy Kumar Chowdhury (35) S/O Chandu Chowdhury of village Bonkata PS Manbazar District Purulia and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Sanjoy Kumar Chowdhury (35) tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Sanjoy Kumar Chowdhury (35) S/O Chandu Chowdhury of village Bonkata PS Manbazar District Purulia as per law and arrange for its investigation.
