Sir,

In producing here with one accused person Niranjon Mahato (60) S/O Lt. Kandru Mahato of Village - JablaPS- Manbazar District Purulia along with following seized articles viz-

- 1) 15 (Fifteen) Ltrs ID liquor within a Jarikane
- 2) 04 pieces plastic glass

I S.I. Mahadeb Rana of Manbazar PS do hereby lodged a complaint against accused namely Niranjon Mahato (60) S/O Lt. Kandru Mahato of Village - JablaPS- Manbazar District Purulia to the effect that today (02.02.2021) at 16:35 hrs. I received a telephonic information from a reliable source that one Niranjon Mahato (60) S/O Lt. Kandru Mahato of Village - JablaPS- Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 70 Dtd 02.02.21. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1316 Ujjwal Mandal, C/441 Santa Das rushed to the spot for raid by Govt. vehicle. At about 16 :55 hrs. myself along with force reached at Jabla village and held raid in the house of Niranjon Mahato (60) S/O Lt. Kandru Mahato of Village - JablaPS- Manbazar District Purulia and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Niranjon Mahato tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.


Hence, I therefore pray that a specific case may kindly be started against arrested accused person Niranjon Mahato (60) S/O Lt. Kandru Mahato of Village - Jabla PS- Manbazar District Purulia as per law and arrange for its investigation.
