Sir,

In producing here with one accused person Bhandal @ Anil Bauri (48) S/O Hadan Bauri of Village +PO- Pedda PS- Manbazar District Purulia along with following seized articles viz-

- (1) 22 (Twenty two) Ltrs ID liquor within a Jarikan
- (2) 15 pieces plastic glass

I SI Soumen Kumar Panda of Manbazar PS do here by lodged a complaint against accused namely Bhandal @ Anil Bauri (48) S/O Hadan Bauri of Village +PO- Pedda PS- Manbazar District Purulia to the effect that today (10.02.2021) at 18:45 hrs, I received a telephonic information from a reliable source that one Bhandal @ Anil Bauri (48) S/O Hadan Bauri of Village +PO- Pedda PS- Manbazar District Purulia has stocked ID liquor illegally and selling the same after hike price for his personal gain. I noted this information in GDE vide Manbazar PS GDE No-395 Dtd 10.02.2021, I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1252 Sunil Kumar Mandal & NVF/537 Aat Kumar Mahato both of Manbazar PS District Purulia rushed to the spot for conducting raid by Govt. vehicle. At about 19:05 hrs myself along with force reached at Pedda village and held raid of Bhandal @ Anil Bauri and found that said person selling ID liquor. Seeing the Police party some persons fled away and said Bhandal @ Anil Bauri tried to concealed himself but he was able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Bhandal @ Anil Bauri (48) S/O Hadan Bauri of Village +PO- Pedda PS- Manbazar District Purulia as per law and arrange for its investigation.
