
In producing here with arrested accused persons namely (1) Sankar Paswan @ Bhima (30 Years) S/O-Arun Paswan of Goalapara, Sanctoria (2) Md. Aftab (22 Years) S/O- Md. Dildar of Sanctoria Shishubagan, Bhāgabandh Para and (3) Sonam Shaw @ Guddu (31 Years) S/O- Om Prakash Shaw of Nepali Dhawra, Sanctoria all are under PS-Kulti, Dist-Paschim Burdwan; to the effect that today 10.02.2021 at about 00.35 Hrs in course of night mobile duty accompanied with SI Kalyan Kumar Sakha, C/939 Laltu Paul, C/1304 Dhananjay Mondal and C/584 Madhab Chandra Majee all of Neturia PS, received credible source information that a gang of dangerous dacoits being armed with deadly weapons assembled at nearby Subhash Road boarded in an Auto and preparing themselves for committing dacoity on Purulia – Barakar road upon running vehicles. Accordingly I intimated you over mobile phone and as per your direction myself accompanied with officer and force immediately proceeded to the anticipated place of assembly at 01.05 hrs to work out the information and reached near to the anticipated place at 01.25 Hrs leaving the Police vehicle No- WB 56C/8994, led on ambush being led by the source and noticed that 07/08 persons assembled at an open field by the side of Subhash Road and those persons are whispering for preparing themselves to commit dacoity upon running vehicles on Purulia – Barakar Pitch road as it could be audible from the talks of the assembled criminals. We watched them from 01.45 hrs upto 02.05 hrs and cordoned them. Then after disclosing our identity, I commended them to surrender but they paid no heed to it and started to run away. We succeeded in rounding up only 03 (Three) of them at 02.35 Hrs while the rest 04/05 escaped away despite hot chase after them. The detained persons disclosed their identity as mentioned above. We searched the above noted accused persons and recovered one country made pipe gun, length approx 20.5 cm with wooden butt (Length about 12 cm), barrel – 10.5 cm from the left side waist of Md. Aftab and one round live .303 ammunition from his right side pocket, one bhojali, length approx 45 cm with 10 cm wooden butt from the left side waist of accused Sankar Paswan @ Bhima and one iron rod from accused Sonam Shaw @ Guddu and also seized one Auto having registration No- JH 10BT/9642 from the place of assembly of the accused persons. Then, I arrested them and seized one country made pipe gun with one round live .303 ammunition, one bhojali and one iron rod and one Auto from their possession under proper seizure list duly signed by arrested accused persons and witnesses as Alamat property in c/w this case. On interrogation arrested accused persons stated that they have assembled there for committing road dacoity, boarded on above noted seized auto but they could not say about the name of other co-accused persons, During search and seizure I have tried to procure public witnesses to put down signature in the seizure list but the time is dead hour of night so no any person available there. Under such circumstances it is reasonably believed that the above noted accused persons were assembled there for committing road dacoity on

Purulia - Barakar road in between Subhash Road - Harmaddih. In course of arrest, I prepared arrest memo, inspection memo and seizure list at the spot after observing all formalities of arrest rule and ground of arrest duly communicated to them.


