



Complainant and the marriage between the accused No.3, and Abhijit Kanjilal was solemnised an according to Hindu rites and customs and since after marriage xixee said Sanghmitra Banerjee, started to created pressure upon his husband to leave his old sick parents and make an arrangement for the seperate mess and when Abhijit Kanjilal was disagreed with the accused No.3, she was furiated and started

to abused your Complainant her son(Witness No.1)her husband

That, from very inception of marriage the accused No.1

2,3,4,5,6 created pressure upon the son of the Complainant

4. That the accused No.3, is the uncivilized lady and she always intend to lead a free life as well as a luxurious life and she is in habit to keep the illicit relationship with some antisocial male persons and as and when the Witness No.1, asked her not to lead such type of life and tried to mend her and requested her to control her activities

No.3, became arrogant and started to abused to your Complaina her son and other family members. On various occassion the accused No.3, assaulted your Complainant and Witness No.1,

considering the future of her two daughter but the accused





with fist Junion and Chief Parti like Br and brows and abused them in most filthy langauges like Bhikhari, spinsterman, Bajjat, etc. etc. but the Complainant and Witness No.1, was kept bum considering the future of his two daughter.

- That since after marriage the accused No.1,2,4,5 & 6 always enterfared in the family matter of the Complainant and from very beginning marriage they always indulged the accused No.3, to created torture upon the witness No.1, both physically and mentally and as and when the witness No.1, requested the accused No.3, not to ill-behave with his parents and other family members she was threatened him that she would file false case against him and his family members and teach them good lesson.
- That the accused No.3, is very dangerous and desperate lady and she has unholy nexus with some antisocial persons and she always tried to grab the whole property of the witness No.1, and created pressure upon him and the complainant to transfer all the property in her name and when the complainant was not ready to transfer the property in her name she was threatened that she would murder her son Abhijit Kanjilal at any cost.
- That the situation reached its vertex on 02.2.2019, when the accused No.3, left her matrimonial home in her own will and on various occassion the witness No.1,and the $C_{\text{cmplainant}}$ and there family members tried to convinced the accused No.3, to come back to their house but she declared that she never intend to live with the Witness No.1, as husband and wife as she never like and love him she demanded Rs. 10,00,000/- from the Witness No.3, and pressure upon him to give her divorce and continously threatened him with dire consequences.

8. That on 13.12.2020, at about 3.30 P.M., the accused No. 1,2,3,4,5,6 came into the house of the Complainant and entered their house forcefully and started to abused your Complainant and her son witness No.1, in most filthy languages and when the Complainant and her son requested them not to abused they started to assaulted your Complainant and her son mercilessly. The accused No.1,2,3,4,5 & 6 assaulted the Witness No.1,Abhijit Kanjilal by iron rod and Lathi, and they also stabbed him by knife following which he was sustained grevious bleeding injury on his nead and left arm, finally they pressed the throat of the son of the Complainant and attempt to murdered him.

9. That when the accused persons assaulted mercilessly to the son of the complainant, your complainant being a mother and her husband Sukhdeb Kanjilal, they also assaulted by the accused persons and sustained injury. When the accused person assaulted your Complainant and her son, they was started hue and cry and on hearing then the para people come on the spot and on seeing them the accused person left after stolen

M.55,000/-(Rupees fifty thousand)only, and a gold ring from the house of the Complainant. The accused persons assaulted your Complainant and her husband and her son Abhijit Kanjilal mercilessly which may cause death of the Witness No.1, Abhijit

10. That afterthe incident the complainant, witness No.1,2,3, 4x went to the Nituria Police Stat on and narrate the whole incident and as they witness No.1, was heavily injured the cops of Nituria P.S., sent them to Harmadin C.H.G., Purulia, for treatment and the Doctor & was admitted the Witness No.1, (injured) and medically treated him—and thereafter the Witness No.1, Abhijit Kanjial was bed—ridden and sitk and the Complt.

on various occassion went to Nituria Police Station to know the 2021 the fate of the case but on 5th January, they asked your Complainant to go to Court and file case against the accused persons as they are otherwise busy.
