2. That accused No.3, is the daughter-in-law of the Complainant and the marriage between the accused No.3, and Abhijit Kanjilal was solemnised ~~xx~~ according to Hindu rites and customs and since after marriage ~~xxxx~~ said Sanghmitra Banerjee, started to create pressure upon his husband to leave his old sick parents and make an arrangement for the separate mess and when Abhijit Kanjilal was disagreed with the accused No.3, she was infuriated and started to abuse your Complainant her son (Witness No.1) her husband and other family members.

3. That, from very inception of marriage the accused No.1, 2, 3, 4, 5, 6 created pressure upon the son of the Complainant ~~put~~ separate mess and when the Witness No.1, Abhijit Kanjilal was disagreed with them, they threatened him and his family members and asked that they would false complain against them and sent them behind the bar. The accused No.3, always threatened the Witness No.1, and his family members if he disagreed to make an arrangement for separate mess she will lodge false complain against the Complainant her son and her other family members and sent them behind the bar.

4. That the accused No.3, is the uncivilized lady and she always intend to lead a free life as well as a luxurious life and she is in habit to keep the illicit relationship with some antisocial male persons and as and when the Witness No.1, asked her not to lead such type of life and tried to mend her and requested her to control her activities considering the future of her two daughter but the accused No.3, became arrogant and started to abuse your Complainant her son and other family members. On various occasions the accused No.3, assaulted your Complainant and Witness No.1,

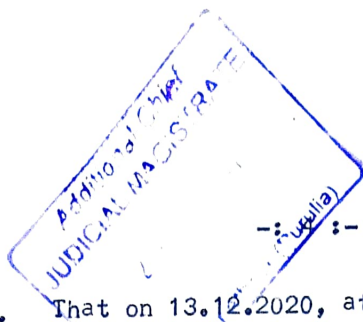

with fist and blows and abused them in most filthy languages like Bhikhari, spinsterman, Bajjat, etc. etc. but the Complainant and Witness No.1, was kept mum considering the future of his two daughter.

5. That since after marriage the accused No.1,2,4,5 & 6 always entered in the family matter of the Complainant and from very beginning marriage they always indulged the accused No.3, to create torture upon the witness No.1, both physically and mentally and as and when the witness No.1, requested the accused No.3, not to ill-behave with his parents and other family members she was threatened him that she would file false case against him and his family members and teach them good lesson.

6. That the accused No.3, is very dangerous and desperate lady and she has unholy nexus with some antisocial persons and she always tried to grab the whole property of the witness No.1, and created pressure upon him and the complainant to transfer all the property in her name and when the complainant was not ready to transfer the property in her name she was threatened that she would murder her son Abhijit Kanjilal at any cost.

7. That the situation reached its vertex on 02.2.2019, when the accused No.3, left her matrimonial home in her own will and on various occasions the witness No.1, and the Complainant and their family members tried to convince the accused No.3, to come back to their house but she declared that she never intend to live with the Witness No.1, as husband and wife as she never like and love him she demanded Rs.10,00,000/- from the Witness No.3, and pressure upon him to give her divorce and continuously threatened him with dire consequences.

8. That on 13.12.2020, at about 3.30 P.M., the accused No. 1,2,3,4,5,6 came into the house of the Complainant and entered their house forcefully and started to abused your Complainant and her son witness No.1, in most filthy langauges and when the Complainant and her son requested them not to abused they started to assaulted your Complainant and her son mercilessly. The accused No.1,2,3,4,5 & 6 assaulted the Witness No.1, Abhijit Kanjilal by iron rod and Lathi, and they also stabbed him by knife following which he was sustained greivous bleeding injury on his head and left arm, finally they pressed the throat of the son of the Complainant and attempt to murdered him.

9. That when the accused persons assaulted mercilessly to the son of the complainant, your complainant being a mother and her husband Sukhdeb Kanjilal, they also assaulted by the accused persons and sustained injury. When the accused person assaulted your Complainant and her son, they was started hue and cry and on hearing then the para people come on the spot and on seeing them the accused person left after stolen Rs.55,000/- (Rupees fifty thousand) only, and a gold ring from the house of the Complainant. The accused persons assaulted your Complainant and her husband and her son Abhijit Kanjilal mercilessly which may cause death of the Witness No.1, Abhijit Kanjilal.

10. That after the incident the complainant, witness No.1,2,3, * went to the Nituria Police Stat on and narrate the whole incident and as they witness No.1, was heavily injured the cops of Nituria P.S., sent them to Harmadih C.H.G., Purulia, for treatment and the Doctor * was admitted the Witness No.1, (injured) and medically treated him, and thereafter the Witness No.1, Abhijit Kanjilal was bed-ridden and sick and the Complt.
