Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accused person namely Aadesh Bouri (38 Years) S/O- Sricharan Bauri of Vill-Bora, PS-Neturia, Dist-Purulia with seizure of 14 pcs Sealed bottles of Captain Country spirit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (03.02.21) while I, SI Sujoy Kundu along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-127 Dt. 03.02.21 and acting on source information after consulting you at about 17:35 hrs reached at Murgabani village near MSPL factory and held raid in the tea shop of Aadesh Bouri (38 Years) S/O- Sricharan Bauri of Vill-Bora, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Aadesh Bauri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 14 pcs. Sealed bottles of Captain Country spirit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Aadesh Bouri (38 Years) S/O- Sricharan Bauri of Vill-Bora, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1224 Gajan Murmu (2) C/939 Laltu Paul and (3) C/1304 Dhananjay Mondal all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Aadesh Bouri (38 Years) S/O- Sricharan Bauri of Vill-Bora, PS-Neturia, Dist-Purulia under proper section of law.
