Sir.

In producing herewith one seized Tractor with trolley having registration No- WB 55A/2679, Chassis No- JDNO1784 loaded with raw coal of 06 Quintal (approx) do hereby lodge a complaint to the effect that on (25/02/2021) I, SI Chandan Kumar Sen, along with C/1260 Santosh Saren, C/584 Madhab Chandra Majee all of Neturia PS were engaged in special mobile duty vide Neturia PS GDE No- 1168 Dt. 25.02.21 & CC No- 484/21 Dt. 25.02.21. In course of Mobile Duty, at about 14:45 hrs when we reached at Gobag More, I received an credible source information to the effect that one Tractor having registration No-WB 55A/2679 loaded with illegal coal coming from Rangdih village side and will transport the same to Raghunathpur side in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Bhasko village More through Purulia - Barakar pitch road. At about 15.05 hrs we reached at Bhasko More beside Purulia - Barakar pitch road under Neturia PS and found one tractor was coming from Rangdih village side, suddenly the tractor stopped about 90/100 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards jungle side. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding area to find out the person but failed to trace out him. On search we found that Tractor having registration No- WB 55A/2679, Chassis No- JDNO1784 is loaded with raw coal of 06 Quintal (approx).

So, there is reason to believe that the driver and registered owner of the said tractor and owner of coal seized from tractor have collected the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly, I seized the said Tractor having registration No- WB 55A/2679, Chassis No- JDNO1784 with raw coal of 06 Quintal (approx) under proper seizure list duly signed by available witnesses. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on that spot.

Under the above circumstances a specific case may kindly be started against the (1) Driver of Tractor No- WB 55A/2679, (2) Registered owner of Tractor No- WB 55A/2679 and (3) Owner of coal seized from Tractor No- WB 55A/2679 under proper section of law.
