Respected Sir,

In producing herewith one arrested accd. person namely Bhot Mahato (34yrs) S/o Sajan Mahato of Vill.- Tentulhity, PS- Para, Dist. Purulia with seized article i.e 17 (Seventeen) pcs sealed bottles of Country Spirit styled as "DIL SE" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list, I beg to submit that today (08.02.2021) during my evening mobile duty I received credible source information that one Bhot Mahato (34yrs) S/o Sajan Mahato of Vill.- Tentulhity, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 18.15 hrs to 18.45 hrs I held raid in the house of Bhot Mahato (34yrs) S/o Sajan Mahato of Vill.- Tentulhity, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as 'Dil SE'. On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license. So I seized 17(Seventeen) bottles of 'Dil SE' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guidelines provided by NHRC/WBHC and informed his family members.




