Mundar Paswan of Vill- Bajkartar, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 19.45 hrs to 20.35 hrs I held raid in the house of Bijoy Paswan (57 Yrs) S/o Lt. Mundar Paswan of Vill- Bajkartar, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as 'DIL SE'. On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license. So I seized 17 (Seventeen) bottles of 'DIL SE' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them.
