Sub: Request for lodging F.I.R. against accused Manbodh Dutta(50 yrs), S/O-Lt. Baul Dutta of Vill+PO+PS- Puncha PS Dist- Purulia u/s- 46A (c) of B.E. Act 1909.

Sir,

In producing herewith arrested accused person Manbodh Dutta(50 yrs), S/O-Lt. Baul Dutta of Vill+PO+PS- Puncha PS Dist- Purulia under Arrest Memo, Inspection Memo alongwith seized articles viz. (i) one white plastic jarican having approx 09 ltrs ID liquor (ii) four numbers of plastic glass (iii) one bottle of ID Liquor approx 375 ml. as sample of Sl. No.- 1 under proper seizure list and being labeled properly, I beg to report that today at 16.02.2021 at about 17.25 hrs. received a telephonic information from source that one person namely Manbodh Dutta(50 yrs), S/O-Lt. Baul Dutta of Vill+PO+PS- Puncha PS Dist- Purulia was selling ID liquor illegally at Barameshya village. Accordingly after obtaining permission from O/C Puncha PS I SI Prasanta Sau along with ASI Anup Roy , ASI Sanjay Ghosh and C/692 Ukil Ch. Mahato and C/823 Swapan Kr. Barik left for working out the information after diarizing the matter in GD vide Puncha PS GDE No- 1054 dated- 16.02.2021. We reached at Barameshya village and keeping the vehicle at a reasonable distance we proceeded to the house of Balika Bauri, W/O- Lt. Rajen Bauri of vill-Barameshya, PS-Puncha, Dist- Purulia as being shown by the source from distance. We entered in the house and found one person was selling ID liquor and some persons were drinking in the courtyard of the house. Seeing the police all persons fled away leaving some plastic glasses but he could not flee away. We apprehended him and on searching the house we recover (i) one white plastic jarican having approx 09 ltrs ID liquor (ii) Four number of plastic glass (iii) one bottle of ID Liquor approx 375 ml. as sample of Sl. No.- 1 On being interrogated the person revealed his identity as Manbodh Dutta(50 yrs), S/O-Lt. Baul Dutta of Vill+PO+PS- Puncha PS Dist- Purulia. On asked he could not produce any license in favour of selling, keeping or possessing ID liquor Accordingly in between 18.55 hrs to 19.15 hrs I seized (i) one white plastic jarican having approx 9 ltrs ID liquor (ii) Four numbers of plastic glass (iii) one bottle of ID Liquor approx 375 ml as sample of Sl. No.- 1 from his possession after labeling and sealing properly and took sample of each of the items and arrested him observing all the formalities regarding arrest in between 18.55 to 19.15 as his offence comes under the ambit of 46A (c) of B.E. Act 1909. The whole process was completed in between 18.55 hrs to 19.35 hrs.

Hence a specific case may kindly be started and arrange for its investigation.
