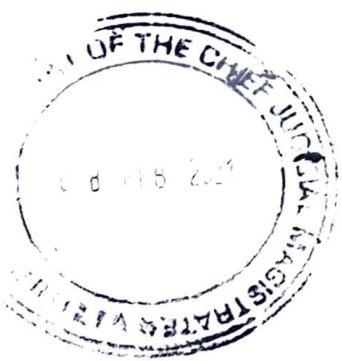

- 6). That after death of Parijita Ghosh, Complainant locked the house and started his faily life with his Business.

That on 18.01.2021 complainant came to know from a neighbour that Moumita Kundu i.e, Accused no. 1 and sonali Ghosh i.e, accused no. 2 broke the lock and entered the house and threw all articles of Parijita Ghosh and sk. Sarafat from the house to outside so, the complainant rushed towards the house and after reaching there he noticed that his Rs. 21,000/- which he kept in a bag that was missing and two golden ring, one pair of Golden Earring two golden Bengal One Mobile are missing. The complainant is sure that accused no. 1 Moumita Kundu and accused no. 2 sonali Ghosh stole those articles and money.

8). That More over the accused persons threaten the complainant with " Lathi " and " Boti " that they may falsely implicate the complainant in a false case and threaten the complainant to leave the house.

9). That the complainant informed this matter to Purulia (T) P.S. by registry post<sup>ed</sup> as well as S.P. Purulia but Purulia (T) P.S. and S.P. Purulia have not taken any step against the accused person.

So, the complainant is liable to take shelter before the Court of law for justice.

It is respectfully prayed that your Honour would be pleased to accept the Petition U/s 156(3) Cr. P.C. and directed to Purulia (T) P.S. to treat the same as a F.I.R. and be pleased to pass necessary order/ orders.
