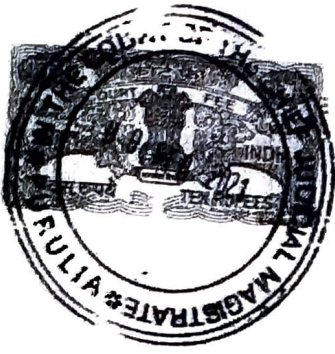

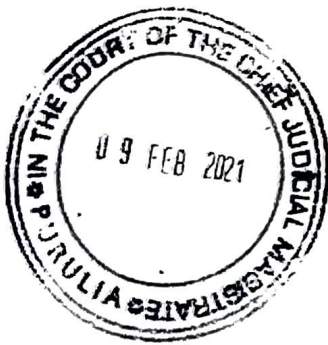

The humble petition of the complainant

Most respectfully showeth :-

1. That on the date of occurrence i.e. on 07/01/2021 the complainant and her husband Sk. Alladh (witness No.2) came to learn that her father-in-law Sk. Farid died and as such complainant informed her parents namely, Sk. Akhtar (Witness No.6) and Ahedul Bibi (witness No.7) and accordingly the complainant's parents came from their house namely, Gorabari under Neturia P.S. to see the dead body and to perform funeral rituals and that accordingly on said 07/01/2021 at about 2.00 P.M. the complainant accompanied by her husband Sk. Alladh, elder son Sk. Arman (witness No.2) Minor daughter Paribaru and parents namely, Sk. Akhtar and Ahedul Bibi went to the house of Sk. Bofad (brother of complainant's husband) to see the

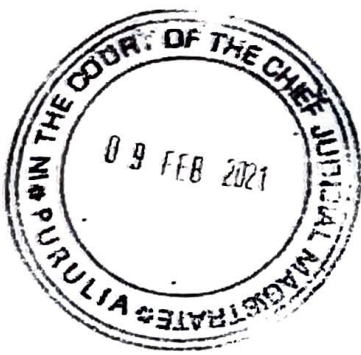

dead body of said Farid and to perform the funeral rituals but accused Sk. Bofad seeing the complainant and her husband, sons and parents started abusing them and also threatened them with dire consequences and as such the complainant and her husband and other companions aforesaid being frightened ran out of the house of Sk. Bofad out of fear of lives ^{and} they anyhow entered into their house to which accused Sk. Bofad and his associates namely, accused No.2 to 11 aforesaid forming an unlawful assembly being armed with Lathi, Axe, Iron Rod, Bhojali etc. criminally trespassed into the house of the complainant in a joint concert and thereafter accused Sk. Bofad with an attempt to commit murder tried to hit the complainant on her head by axe but the complainant saved herself anyhow but she sustained severe cut injury on the left side of her forehead i.e. adjacent to her left eye which caused severe bleeding cut injury and she fell down on the ground. The complainant's elder son Sk. Aman seeing her mother injured came to save whereupon accused Sk. Daud's son accused Sk. SaifK assaulted Sk. Aman by a Rod with a view to do away his live but he anyhow got saved but at the same time Sk. Aman sustained bleeding injury on his nose and thereafter all the 11 accused persons including accd. Sk. Kadir tried to kill complainant's husband by Tangi to which he ran out of the house out of fear of life and thereafter all the 11 accused persons chased complainant's husband but could not succeed to catch him and further that all the accused persons, in order to kill, confined complainant's mother Ahedul Bibi and her minor son Sk. Altaj and Faribam in a room by bolting the door thereof under lock and key and after that accused Marufa Bibi and Alima Bibi snatched

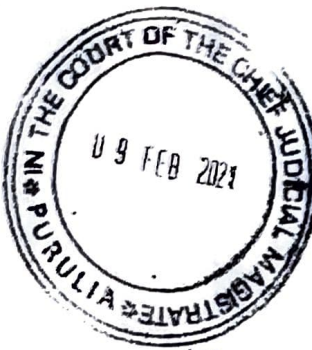

the silver chain from the neck of the complainant weighing about 4 bhories amounting to Rs. 3000/- and thereafter all the accused persons damaged the motor cycle (WB-562/3560) of the complainant's husband causing loss of atleast Rs. 6000/-

2. That the complainant being helpless shouted for help and with the help of local people and her father and elder son Aman went to Purulia(M), F.S. and reported the incident to which the Police came to the P.O. and Police rescued complainant's mother and her 2 minor children aforesaid and after that the complainant in order to save herself and other inmates of the family from the clutches of the accused person went to her paternal house at village-Gorabari under Neturia P.S. and on the way the complainant and her elder son Sk. Aman got medically treated at Hamardih C.H.C. under Neturia P.S.

3. That as the complainant and her relatives got severely frightened and injured they could not enter into their house at Village-Chapra nor they could lodge F.I.R. on the date of incident but on the following day, i.e. on 08/01/2021 she anyhow went to Purulia(M), P.S. and lodged ^{S. written} F.I.R. against all 11 accused persons enclosing the medical papers in respect of herself and her son Sk. Aman to which the duty officer concerned assured to take necessary steps against the accused persons and also assured giving relief but it is unfortunate that nothing

and
tangible was effected so far as such the complainant informed the matter before S.P.Purulia on 14/01/2021 by speed post enclosing the copy of F.I.R. dated 08/01/2021 and the medical papers dated 07/01/2021 relating to complainant and her son Sk. Arman but it is further unfortunate that about a month elapsed from the date of incident but neither the Purulia(M) P.S. nor the S.P.Purulia took any positive steps against the miscreants. Hence the complainant being helpless has come before this Ld. court for relief and justice.

It is therefore prayed that the O/C Purulia(M) P.S. may kindly be directed to investigate the case u/s 156(3) Cr.P.C. treating this complaint petition as F.I.R.
