In producing here with arrested accused persons namely (1) Bibek Bauri (22 Yrs) S/O Lt. Haru Bauri (2) Sagar Bauri (30 Yrs) S/O Gouranga Bauri both of Sinderpatri, Ward No- 10, PS.-Purulia(T), Dist.-Purulia under arrest along with seized articles as per seizure list i.e. 36 bottles of country spirit marked as DILKHUS 600 ml each, 04 empty bottles, 10 Plastic Glass, I ,SI Keshab Chatterjee of Purulia (I) PS do hereby lodged a written complaint against the above noted accused persons to the effect that today (20.02.2021) myself along with C/983 Radha. Kanta Kisku and C/1234 Mantulal Mondal were holding raid against illicit selling of liquor at PS area vide GDE No-1114, Dated 20.02.2021. In course of said raid programme in between 17:05 hrs. to 17:35 hrs. I received secret source information that one person namely Bibek Bauri (22 Yrs) S/O Lt. Haru Bauri, of Sinderpatti, Ward No- 10, PS.-Purulia(T), Dist.-Purulia with his associate member Sagar Bauri (30 Yrs) S/O Gouranga Bauri of Sinderpatti, Ward No- 10, PS.-Purulia(T), Dist.-Purulia are selling country spirit illegally without having any licence/authority at Over Bridge near, Telkal Para under Purulia(T) PS. After receiving such information I informed the matter to I/C Purulia (T) PS over mobile phone and as per his instruction myself along with force left for the desired place to work out the information. Reaching at Over Bridge near Telkal Para I noticed that the selling of country spirit was going on there and seeing the police all customers managed to escape, but we could able to apprehend the above noted accused persons. On demand of papers they failed to produce any valid documents in support of selling country spirit. So I seized all the implicating articles as noted above under a proper seizure list from their exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused persons and witnesses among which one bottle of country spirit was kept as sample file with label. During interrogation they confessed their guilty so, I arrested them after observing all the formalities issuing memo of arrest as the accused persons are liable for prosecution u/s 46A(c) of The Bengal Excise Act, 1909.

I therefore pray that a specific case may kindly be started against the accused persons namely (1) Bibek Bauri (22 Yrs) S/O Lt. Haru Bauri (2) Sagar Bauri (30 Yrs) S/O Gouranga Bauri both of Sinderpatti, Ward No- 10, PS.-Purulia(T), Dist.-Purulia U/S 46A(c) The Bengal Excise Act,1909, and arrange it's regular investigation.
