He also beats up my children. Yesterday night the torture become unbearable for me and my children. Before, three years ago for his misbehave his mother and father kick out from their house. When my children husband Amar Nath Gupta 70 Binod Prasad Gupta of Dulmi Bhubaneswar, Ward No-7, beaten me by sticks and Rod and threatened my life and finally he pushed me and Anandi Kumari Gupta (15) and Yash Raj Gupta (9) out of the rented house where we stayed. He was drunk and fully out of control and after he become fully addicted we entered the house at around 1 1/2 hours. We were standing alone but no was

nearby to help us.
