Sir.

In producing here with the arrested accused person namely Manoj Swarnakar (30) S/o Basudeb Swarnakar of Beldanga, PS - Raghunathpur, Dist.- Purulia along with seized articles (1) One Black colour Honda Shine Motor cycle without number plate bearing Engine No - JC65E70133174, Chassis No ME4JC652EF7040621 and (2) One improvised country made one shutter fire arms and one round live ammunition.

To the effect that, Today on 06.02.2021 at about 19:25 hrs while I SI Goutam Kumar Bangal accompanied with ASI Amal Kr Pati, C/431 Surendra Kr Dubey, C/351 Kanailal Bauri, C/929 Rajendra Das of Raghunathpur PS were performing anti crime Naka checking duty on Raghunathpur - Bankura road near at Chinpina Rail Gate under Raghunathpur PS vide Raghunathpur PS GDE No 260 dated 06.02.2021 and CC No. 409/2021 and found the above noted person was coming from Beldanga side by his motorcycle as stated above. On seeing the police party the said rider tried to change his direction to flee away. After hot chase we able to apprehend him and asked him to produce documents in respect of possession of such motorcycle and why he tried to flee away? On demand he neither produced any valid documents in this regard nor answered why he changed his direction and fleeing away. His attitude and behaviour found highly suspicious. On being suspicion I searched the said person and found One improvised country made one shutter fire arms having butt, barrel and trigger and one round live ammunition found loaded into it. Length of Barrel is approx 06 (Six) inch, Body is approx 04 (Four) inch and the Butt is approx 04 (Four) inch along with trigger and firing pin was kept in his left side of the waist under is full pant. Moreover he made different statements in different times regarding his identity as well as keeping possession of such motorcycle and fire arms. After long interrogation he disclosed his identity as stated above and informed me that he was trying to conceal the motorcycle and disperse the same to his well known persons.

. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms, ammunition and Motorcycle. Hence there is adequate reason to belief that the said motorcycle was stolen one and the accused Manoj Swarnakar was dealing with motorcycle for the purpose of business after knowing it to be a stolen one and concealed the same for his business. Accordingly I seized One Black colour Honda Shine Motor cycle without number plate bearing Engine No - JC65E70133174, Chassis No ME4JC652EF7040621 and One improvised country made one shutter fire arms and one round live ammunition, length of Barrel is approx 06 (Six) inch, Body is approx 04 (Four) inch and the Butt is approx 04 (Four) inch along with trigger and firing pin after furnishing seizure list maintaining all formalities and I arrested him after maintaining all legal formalities of arrest. I tried my label best to sign the public witnesses but in vain and in alone place and far distance from villages so none present there, So I unable to put signature of any public witnesses on the seizure list.

I therefore pray that a specific case may kindly be started against the accused person namely Manoi Swarnakar (30) S/o Basudeb Swarnakar of Beldanga, PS - Raghunathpur, Dist.- Purulia under proper section of law and arrange its regular investigation.
