The complainant most respectfully sheweth:-

- That the land bearing Rs. Plot no.109 and 110 situated in mouza Nunurpur under raghunathpur Ps. Within the jurisdiction of your Honour's court had been possessing by the father of the complainant ,Kalu Mia @Ansary since deceased in Rayati right accordingly his name has been recorded in RSROR and LRROR.
- 2. That said Kalu Mia @ Ansary expired leaving behind the complainant as his only legal heir and successor being his only son accordingly the complainant inherited and came into possession over the land mentioned in the schedule below along with other property left by the father of the complainant after his death.
- 3. That the accused No.1 is familiar and known to the complainant and on the basis of that the accused No.1 became aware of the land of the complainant mention below.
- 4. That suddenly on 15/12/2019 the accused No.1 went to the residence of the complainant at village Bamunbad Ps.- Para Dist.- Purulia and asked the complainant whether he want to sale the land mentioned below to the intending purchaser/purchasers, to which the complainant responded and expressions desire to sale with proper consideration money.
- 5. That having consultation with the complainant as regards the above said facts the accused No.1 asked the complainant to deliver his one photo stayed copy (Xerox Copy)of the voter identity card of the complainant, in response to the above said approach the complainant deliverathe Xerox copy of the voter identity card to the accused no.1 on good faith.
- 6. That on 02/01/2020, in the morning the accused No.1 and 2along with one Amin (surveyor) and some unknown persons criminally trespassed into the land mentioned below and started measuring the land without having any consent of the complainant illegally and being aware of the above said facts the complainant along with his some relatives went to the P.O and asked the accused persons why they are measuring the land and in reply to that the accused person told the complainant that the accused No.2 had purchased the land mentioned below by virtue of registered sale deedbearing No.22/2020 with valuable consideration of Rs.4,50,000/from the rightful recorded owner in possession Maharam Ali Ansary.
- 7. That on protest as to the measurement of the land made by the complainant the accused persons left the P.O.
- 8. That having aware of the above said shame transfer the complainant applied for certified copy of the sale deed before authority concerned and received certified copy of the deed and came learn the deed in question has been executed by one fictitious Maharam Ali Ansary in favour of the accused No.2 having received of the consideration amount of Rs. 4,50,000/-.
- That in fact the complainant neither received any consideration amount from the accused No.2 in respect of the land mentioned below nor executed and registered any sale deed in favour of the accused no.2,so it is





evident that the accused persons with the criminal conspirate of each other manufactured a forged sale deed impersonating someone as Maharam Ali Ansary, the present complainant thus the accused persons have committed offence under section 120B,/467,/420/447/34 140 read with section 463 IPC.

- 10. That the complainant went to Raghunathpur Ps. Along with a complaint petition For lodging the same as FIR on 20/2/2020, but Police of Raghunathpur Ps. Did not care for the same, so the complainant sent the complainit by post to the superintendant of Police Purulia for taking action against the accused persons on 24/2/2020, but no good. For which the complainant compelled to file this case before yours honours court.
- 11. That during the covet -19 period the complainant unable to come before court and file the case, earlier.

In view of the facts and circumstances stated above , it is prayed that the complaint petition may kindly be sent to the Raghunathpur Ps for Investigation after treating this as F.I.R under section 156(3) Cr.P.C .
