Thereafter Complainant lodged Complain before the Superintendent of Police, Purulia on 28-12-2020 alleging all matter with prayer to issue direction to Register specific case and no case started by women Police Station the reason known but to him

That, Complainant was leading a happy peaceful marriage life and pleasing her parents in matrimonial house, by her conduct and behaviour as well as providing all service according to her ability and matrimonial alliance/relationship was good and Complainant and her husband used to visit <sup>Pindya</sup> ~~Prindya~~ and by this time both of them was blessed with two children and after few days environment surrounding situation and behaviour towards complainant started changing and she was often insulted with rough and filthy languages and blamed.
- 5. That, on 20-09-2020 and this time she was subjected to physical torture in the hand of the husband and other accused persons by kicks and blows and thereafter forcibly send her to her father's house to bring Rs. ~~50,000/-~~ 30,000/- for the purpose of cow business and further told to bring the money positively otherwise, she would not be allowed to stay and face with dire-consequence and thus they get Rupees 30,000/- and allowed to stay in matrimonial house, <sup>and further told, complainant is down character.</sup>
- 6. That, on 20-09-2020 in the night Complainant forcibly confined in a room with closed door from outside and withdrawn from all foods alongwith systematic torture physical ~~torture~~ assault and one day all the accused persons making pre-plan in mind with intent to finish her life by giving poison in the food by neighbourers by breaking closed doors and send her to her father house for treatment of taking poison.
