This is to inform you that on. date. 19.02.2021 at about 11:00 am unassigned received information over telephonic information by General Manager, Security, ECL, Ho, Sodepur that one team consisting of C.B.I Kolkata, CISF, Task Force, ECL, conducting inspection/raid at Balituri village on. 19.02.2021 at about 10:00 am and during inspection above team found some illegal Burnt coal (un-claimed) stock at Balituri village area. During initial inquiry it has been come to know from reliable sources of C.B.I the above coal was stock at near by house of Gurupada Maji. The quantity of coal is approx 55 (fifty) cement bag - 5. MT (approx). Then Sodepur area security team along with Parbelia Chap security, CISF, ECL, HO, BRT team and task force team ECL reached at above spot and seized the above coal (un-claimed) and now want to hand over you in your police station (Santui Police station) under Purulia Dist. at West Bengal. As per the information received from the Sodepur area management the above area does not come under leasehold area Sodepur area of ECL.

In this regard you are requested to take necessary action and investigation as per proper section of law against the misdoers who involved in the above coal theft, also request you to re-seized coal in your police station for further legal action at your end.
