Sir,

I, ASI Madhu Mangal Bauri, (46 yrs) S/O- Lt. Khagen Bauri along with force return to PS and brought under seizure 01(One) seized Tractor bearing Registration No- WB55B/0832 is attached with a sand loaded trolley and lodged this complaint to the effect that on 04/02/2021, myself along with force C/2694 Subarna Singha Mahapatra and NVF/633 Biswajit Hembram were performing Evening mobile duty as per order vide Tamna PS C.C No- 297/21, Dt- 04/02/2021. During Evening mobile duty at about 19:05 hrs received a credible source information that some owners of the tractors were extracting sand illegally at Kansai river near Telidih Water Pump House. Accordingly, myself along with force left to work out the said source information. Then, we intercept the aforesaid vehicle near Telidih Water Pump House under Tamna PS at about 19:25 hrs and found the above noted tractor was tagged with a trolley loaded with sand. But seeing the Police Party, driver of Tractor and others fled away leaving his Tractor with sand loaded trolley near near Telidih Water Pump House. We tried to apprehend them but failed. So there is every ground to reason to believe that the owner, driver and others of above noted Tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained Tractor. So I seized the above noted Tractor having its Registration No- WB55B/0832 with attached sand loaded Trolley (approx 100 cft).

On return to Tamna P.S., kept the aforesaid sand loaded seized tractor at PS compound and I do here by submitting written complaint before you to start a cog case against the Owner and Driver of the Tractor having its Registration No- WB55B/0832 & others under proper section of law.
