In producing here with 02 (two) arrested accused persons namely i)Goutam Majhi(22) S/O Lurku Majhi, ii)Rajesh Majhi (21) S/O- Kalebar Majhi both of Vill + P.O- Satra, P.S.- Arsha, Dist-Purulia along with two seized vehicles (Tractors) having Reg. Nos- i) WB37B/3951(Engine No- S324 C24829) and ii) WB55B/2912 (Engine No- RKH2EAN3000 & CHASSIS No- MBNABAEXPKRH08531) attached with sand loaded trolley approx 100 cft. each. The fact in brief is that on 20.02.2021 during evening mobile duty at PS area vide Tamna PS CC No- 410 Dated- 20.02.2021 at Tara more under Tamna PS at about 20:15 hrs received a credible source information that two vehicles (Tractors) having Reg. Nos- i) WB37B/3951 and ii) WB55B/2912 are carrying sand illegally and coming from Amchuria village side & going towards Chakaltore under Tamna PS. Accordingly, myself along with force left to work out the said source information. Then, we went to near Chandradih Nagar more on Purulia - Manbazar road under Tamna PS and started NAKA checking. Seeing two Tractors attached with sand loaded trolley are coming to near Chandradih Nagar more and we gave light and indicated to stop the Tractors. Then we intercept the said Tractors at Chandradih Nagar more (Purulia -Manbazar road) under Tamna PS at about 20:45 hrs and managed to apprehend two persons, one of them was the driver of Tractor bearing Reg. No. WB37B/3951 namely Goutam Majhi S/O Lurku Majhi, of Vill + P.O- Satra, P.S.- Arsha, Dist- Purulia Tractor and another one was the driver of Tractor bearing Reg. No. WB55B/2912 namely Rajesh Majhi S/O- Kalebar Majhi both of Vill + P.O- Satra, P.S.-Arsha, Dist-Purulia. It is noticed that the above mentioned Tractors were attached with sand loaded trolley (each approx 100 cft). On demand, they failed to produce any valid papers in respect of the said Tractors as well as loaded sand though sufficient time was given for produce valid documents/ challan. During interrogation, the drivers of the said Tractors confessed that they in convince with the owner of said Tractors & others are doing this illegal business of sand and they have no Challan/paper for carrying loaded sand. They also confessed that they are doing this illegal business of sand. Then, I arrested the 02 accused drivers of said vehicle (as disclosed during interrogation) as i)Goutam Majhi(22) S/O Lurku Majhi, ii)Rajesh Majhi (21) S/O- Kalebar Majhi both of Vill + P.O-Satra, P.S.- Arsha, Dist- Purulia under proper arrest memo and also seized the 02 Tractors having Reg. Nos- i) WB37B/3951(Engine No- S324 C24829) and ii) WB55B/2912 (Engine No-RKH2EAN3000 & CHASSIS No- MBNABAEXPKRH08531) attached with sand loaded trolley approx 100 cft. each.

On return to P.S., Put the arrested accused persons into the P.S. Lock Up after maintaining all formalities, kept the 02 sand loaded seized vehicles (Tractors) at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Goutam Majhi(22) S/O Lurku Majhi, (ii) Rajesh Majhi (21) S/O- Kalebar Majhi both of Vill + P.O- Satra, P.S.- Arsha, Dist- Purulia (iii) Owner of the vehicle (Tractor) having Reg. No- WB37B/3951(Engine No- S324 C24829) and (iv) Owner of the vehicle (Tractor) having Reg. No WB55B/2912 (Engine No- RKH2EAN3000 & CHASSIS No- MBNABAEXPKRH08531) under proper section of law.
