Sir,

In producing here with one arrested accused namely Chhutu Mukhi (31 Yrs) S/O Benod Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 12 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-50 of each bottle.

I SI Manas Kumar Panda of Adra PS do here by lodged a complaint against accused namely Chhutu Mukhi (31 Yrs) S/O Benod Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia to the effect that on 04/03/21 at about 20:15 hrs I received a telephonic information from a reliable source that one Chhutu Mukhi (31 Yrs) S/O Benod Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia has been stock of country spirit illegally at his House / Shop at Sevanagar Village. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS GDE No-188 dtd.04.03.21. I reached at Sevanagar village at about 20:45 hrs and hold raid in the House/Shop of said Chhutu Mukhi (31 Yrs) S/O Benod Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia and found that the said person selling liquor at his house/shop and after seeing the Police party some person fled away and said Chhutu Mukhi has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Chhutu Mukhi selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Chhutu Mukhi (31 Yrs) S/O Benod Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia under proper section of law.
