I SI Subrata Sadhu of Adra PS do here by lodged a complaint against accused namely Madan Shaw (32 Yrs) S/O Jaharlal Shaw of Vill- Kamlasthan, PS-Adra, Dist- Purulia to the effect that on 05/03/21 at about 17:15 hrs I received a telephonic information from a reliable source that one Madan Shaw has been stock of country spirit illegally at his House / Shop at Kamlasthan Village. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS GDE No-240 dtd.05.03.21. I reached at Kamlasthan village at about 17:45 hrs and hold raid in the House/Shop of said Madan Shaw and found that the said person selling liquor at his house/shop and after seeing the Police party some person fled away and said Madan Shaw has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Madan Shaw selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Madan Shaw (32 Yrs) S/O Jaharlal Shaw of Vill- Kamlasthan, PS-Adra, Dist- Purulia under proper section of law.
