Sir,

In producing here with one arrested accused person namely Ashwini Mandal (50) S/O Lt. Surjakanta Mandal of vill Rugri, P.S.-Arsha Dist-Purulia along with following seized articles.

1) One white colour plastic container with approx 09 ltrs. of ID liquor. (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Susanta Mishra of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today 06.03.2021 at about 20:15 Hrs. during my special mobile duty receive source information over telephone that the above noted accused has been selling ID liquor in his house Rugri Village. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/-628 Giridhari Bauri of Arsha PS and C/-310 Arun Pal of SAP 7th Bn. Camp at Arsha PS rushed to the house to work out the information. Vide Arsha PS CC No.535/21 dtd. 06.03.2021 and GDE No. 243 Dtd. 06.03.2021 Reaching at Rugri village we fixed-up the house of above noted accd. person and found that the selling Id Liquor was going on there and getting seen of police all customers were managed to escape, but we able to apprehended the above noted accused person. On demand of papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which Approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt so, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Ashwini Mandal (50) S/O Lt. Surjakanta Mandal of vill Rugri, P.S.-Arsha Dist-Purulia under proper section of law.
