Sir,

In producing here with one arrested accd namely Rameswar Mudi (57) S/O Lt. Pahalu Mudi of vill Birchali P.S.-Arsha Dist-Purulia along with following seized articles as noted below-

1) One white colour plastic container with approx 16 ltrs. of ID liquor (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Abir Kr. Paine of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 13.03.21 at about 18:15 hrs during my mobile duty received source information over telephone that the above noted accused is selling liquor illegally and clandestinely at Birchali village under Arsha PS, Dist- Purulia. On receiving the reliable source information I communicated with O/C Arsha PS over phone and as per his instruction I along with force of Arsha PS, C/- 970 Dolon Biswas C/- 583 Khirod Baran Sardar both of Arsha PS rushed to the spot to work out the information. Reaching at Birchali at 18:45 hrs. we fixed-up the house of above noted accused person and noticed that he was selling ID liquor and seeing the police approaching, all persons started to flee away. But after a brief chase we were able to apprehend the above noted accused person. On demand he failed to produce any valid documents in support of stocking and selling ID liquor, So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labelled duly signed by the accused persons and witnesses among which approx 500ml was kept as sample file with label. During interrogation he confessed his guilt, so I arrested him after observing all the formalities issuing memo of arrest as the accused person is liable for prosecution under proper section of law.

I therefore pray that a specific case may kindly be started against the accused namely Rameswar Mudi (5) S/O Lt. Pahalu Mudi of vill Birchali P.S.-Arsha Dist-Purulia under proper section of law and arrange for its regular investigation.
