Sir,

In producing herewith accused Bachan Rojput @ Aghori (27Yrs), S/O- Lt Chaitu Aghori of vill- Misirdih, PS- Arsha, Dist- Purulia, with one improvised country made fire arms and one round of live ammunition, I SI Abir Kumar Paine beg to state that on 14/03/21 at 18.25 hrs , I received a source information through my cell phone that one person is moving aimlessly and suspiciously at Mishirdih more under Asha PS area. His movement was very much suspicious in nature.

Receiving such information, diarized the fact in G.D vide GDE No. 575 Dtd. 14.03.21. I informed O/C over phone and as per direction of O/C Arsha PS myself along with force i.e. C/970 Dolon Biswas , C/321 Asish Mandal both are of Arsha PS, Dist- Purulia vide C.C. No. 607/21 dtd 14.03.21 left PS and started for Mishirdih more. At about 19.05 hrs with Bolero Vehicle bearing No WB 55C/9389 reached Mishirdih more and as per identification of my source myself along with force got down from the vehicle at about 19.15 hrs. Seeing us, the above accused attempted to run away but could not succeed. I got hold of his hand and other two accompanied force cordoned him. After detaining him I asked him about his details, purpose of moving there. Firstly he was not revealing the truth but later on repeated questions, he revealed his identity as noted above. I informed him that he would be searched by us and offered him to search our person before our search. Finding no other option, he brought out of his back side of waist from inside the back portion of his pant (1) One improvised country made fire arms made of Iron having length as 26.5 CM from the end point of butt to that of the barrel, length of butt being 13.5 CM approx, barrel 13 CM approx, having trigger and firing pin, etc and also brought out from left pocket of his pant (2) one round of 0.12 bore live cartridge marked as K.F special long range cartridge. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunition, neither he can gave any satisfactory explanation in respect of carrying such arms ammunition. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammunition with proper seizure list and the seized arms and ammunition packed, sealed and leveled in presence of police witnesses since none found there available to witness the seizure in between 19.25 hrs and 20.05 hrs. Hence I arrested him at about 20.05 hrs observing all guideline of NHRC and Honble Appex Court regarding arrest, as he has committed an offence which is punishable U/S – 25/27 of Arms Act.

Hence I alongwith force returned to PS and submitted a complainant against accused Bachan Rojput@ Aghori(27Yrs), S/O- Lt Chaitu Aghori of vill- Misirdih, PS- Arsha, Dist- Purulia to start a specific case under proper section of law.
