Sub: To lodge FIR against owner and driver of Sonalika (blue) tractor vide Regd. number JH09AA-1336 along with trolley.

Sir,

In producing herewith, 01(one) Sonalika DI 734 Tractor (blue colour) having Reg. No- JH09AA- 1336, engine number 3100DL53G506392F3 and Chassis number QSU510521SM along with 01 (one) trolley. Today on 01.03.2021 at about 11:45 hrs. acting on source information, I ASI Tapan Kr. Mahato of Arsha PS along with (i) C/-970 Dolon Biswas of Arsha PS (ii) C/- 156 Bijoy Hansda of SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 492 Dtd. 01.03.21. After we reached at Asharamdih village under Arsha PS, we conducted raid on the Bank of River Kansai under Arsha PS and found that 01(one) Tractor along with 01 trolley attached with by a hinge was present at Asharamdih Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Kansai River, fled away. Police rushed to the Tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, seized the above noted tractor along with trolley and brought the said tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.


Hence, I do hereby lodge this complaint against the owner and driver of tractor vide number JH09AA-1336 along with the trolley and unknown others for investigation.
