Sir,

In producing herewith the arrested accused person namely Gurupada Sing Mura (26 Yrs), S/O-Deben Sing Mura of Vill-Rangamati, PS- Baghmundi, Dist- Purulia along with seized articles 1) 16 ltr (approx) ID Liquor in a white plastic jerican, 2) 18 (Eighteen) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 07.03.2021 during the special raid duty as per source information I along with force vide Suisa OP C.C. No- 319/2021, dtd- 07.03.2021 reached at Rangamati Village at 16.45 hrs and found that the above noted person is selling I.D liquor in his house at Rangamati village under Baghmundi P.S, Dist Purulia. Then, I apprehended him and on demand he failed to produce any valid document from competent authority in respect of stocking & selling of ID liquor. According from his possession I seized 1) 16 ltr ID Liquor (approx) in a white plastic jerican, 2) 18 (Eighteen) Pcs Plastic Glasses as sale proceed which were seized under proper seizure list duly signed by the witnesses. A sample 500 ml ID liquor taken out as sample from the 16 ltr. seized ID liquor and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 17.15 hrs. During arrest I maintained all formalities regarding arrest. I offered him medical treatment but he deny.

The above noted arrested accused person namely Gurupada Sing Mura (26 Yrs), S/O-Deben Sing Mura of Vill-Rangamati, PS- Baghmundi, Dist- Purulia committed an offence U/S-46 A(c) B.E. Act. 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
