In producing herewith the accused person namely Hemanta Hansda (35 Yrs), S/O-Lt-Jitu Hansda of Vill-Bansitar, PS-Baghmundi, Dist- Purulia along with seized articles 1) 13 (Thirteen) liter ID Liquor containing in a white plastic jerican, 2) 05 (Five) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 12.03.2021 during my mobile duty as per source information I along with force 1. C/94 Ratan Kr. Bhoumik, 2. C/319 Saikat Mistri both of Baghmundi P.S, Dist-Purulia reached at Bansitar Village at 19:15 hrs and found that the above noted person is selling I.D liquor at Bansitar Village under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 67 B.E. Act and also seized in his possession 1) 13 (Thirteen) liter ID Liquor containing in a white plastic jerican, 2) 05 (Five) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. All seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 19:45 hrs. During arrest I maintained all formality of arrest rule. I offered him medical treatment but he deny.

The above noted arrested accused person namely Hemanta Hansda (35 Yrs), S/O-Lt-Jitu Hansda of Vill-Bansitar, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E. Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
