Respected Sir,

In producing here with one arrested accused person namely Ram Singh Sardar (48 yrs) S/o- Lt. Barik Singh Sardar of Vill- Bhuita, P.S.- Arsha, Dist. Purulia, A/P- Vill- Daldiri, P.S.- Balarampur, Dist. Purulia along with seized 1) One Plastic Jarican in contained with approx 09 (nine) liters ID liquor, 2) 06 pieces plastic glasses (details of seized articles are mentioned in attached seizure list). I beg to submit that today at about 17:25 hrs. I received a credible source information that one Ram Singh Sardar (48 yrs) S/o- Lt. Barik Singh Sardar of Vill- Bhuita, P.S.- Arsha, Dist. Purulia, A/P- Vill- Daldiri, P.S.- Balarampur, Dist. Purulia is selling ID liquor without any valid license from a open place at Daldiri village under Balarampur P.S. Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Daldiri village area to work out the source information. Thereafter we reached at open place at Daldiri village at about 18:05 hrs as per source information, I along with force held raid in the said open place.

During search with the help of accompany with force, we found that the said person is selling ID liquor from a open place at Daldiri village. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the said ID liquor & plastic glasses (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person namely Ram Singh Sardar (48 yrs) S/o- Lt. Barik Singh Sardar of Vill- Bhuita, P.S.- Arsha, Dist. Purulia, A/P- Vill- Daldiri, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(c) B.E. Act and arrange for its investigation.
