Sir,

In producing herewith arrested accused Bihari Singh (34 yrs) S/O- Lt. Man Singh of Vill- Chutkidih, P.O.- Rangadih, P.S. - Balarampur, Dist - Purulia and brought under seizure

1) One improvised iron made, country made pipe gun having body length about 26 cm, Iron Butt length about 7 cm, Barrel length about 13 cm, trigger, firing pin, 2) 02 (two) live ammunition (8 MM) in unloaded condition, 3) one white colour dirty hand bag under proper seizure list duly signed by the witnesses as well as accused person. I do hereby lodge a complaint to the effect that in course of evening mobile duty at 21:45 hrs. I received a information from my source that 01 (one) person namely Bihari Singh (34 yrs) S/O- Lt. Man Singh of Vill- Chutkidih, P.O.- Rangadih, P.S. - Balarampur, Dist - Purulia get a contract for supplying arms & ammunition, and in this regard he will pass through Kana village more towards Sirgi village which is walkable distance along with some arms & ammunition to supply the same on 12.03.2021 at approx 22:25 hrs. Accordingly I informed the matter to O/C Balarampur P.S and as per direction of O/C Balarampur PS myself along with accompany force along with source reached near Kana village more and kept the vehicle in a safe distance and proceeded at the turning towards the Kachha road of Sirgi village on foot and ambushed. At about 22:45 hrs we found 01 (one) person coming from Chutkidih village side on kachha road by walking. We intercepted him at Ulidih village more. On being asked he disclosed his identity as noted above. On through search on his person, we found One improvised iron made, country made pipe gun having body length about 26 cm, Iron Butt length about 7 cm, Barrel length about 13 cm, trigger, firing pin found in a hand bag along with 02 live ammunition (8 MM). On being asked he failed to produce any valid license or authority for the said arms & ammunition which is found his possession or which arms & ammunition he carrying. So I seized the said arms & ammunition under proper seizure list duly signed by the witnesses as well as arrested him monitoring all the guide line regarding arrest. No public witnesses could be available there.

Under the above fact and circumstances, I therefore pray before you to start a specific case under proper section of law against Bihari Singh (34 yrs) S/O- Lt. Man Singh of Vill- Chutkidih, P.O.- Rangadih, P.S. - Balarampur, Dist - Purulia and obliged.
