Respected Sir,

In producing here with 03 (three) arrested accused persons namely 1) Sarat Singh (55 yrs) S/O- Lt. Muchiram Singh, 2) Mangal Ghasi (35 yrs) S/O- Lt. Lalmohan Ghasi, 3) Haladhar Mandal (31 yrs) S/O- Gurupada Mandal all of Vill- Ghatbera, P.S- Balarampur, Dist.- Purulia along with seized approx 30 (thirty) litters (ID liquor) with a plastic Jarican (details of seized articles are mentioned in attached seizure list). I beg to submit that today at about 11:25 hrs. I received a credible source information that 03 (three) persons namely 1) Sarat Singh (55 yrs) S/O- Lt. Muchiram Singh, 2) Mangal Ghasi (35 yrs) S/O- Lt. Lalmohan Ghasi, 3) Haladhar Mandal (31 yrs) S/O- Gurupada Mandal all of Vill- Ghatbera, P.S- Balarampur, Dist.- Purulia are selling ID liquor without any valid license in the open place near Ghatbera Uparpara Primary School. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Ghatbera Uparpara Primary School area to work out the source information. Thereafter we reached at near Ghatbera Uparpara Primary School at about 12:20 hrs as per source information, I along with force held raid in the open place near Ghatbera Uparpara Primary School.

During search with the help of accompany force, we found that the said persons are selling ID liquor in open place near Ghatbera Uparpara Primary School. On demand, they failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the said ID liquor (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested them after preparing proper arrest memo as they committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused persons namely 1) Sarat Singh (55 yrs) S/O- Lt. Muchiram Singh, 2) Mangal Ghasi (35 yrs) S/O- Lt. Lalmohan Ghasi, 3) Haladhar Mandal (31 yrs) S/O- Gurupada Mandal all of Vill- Ghatbera, P.S- Balarampur, Dist.- Purulia to start a cog case U/S 46A(c)B.E. Act and arrange for its investigation.
