Respected Sir,

In producing here with arrested accused person namely Blue Bishal S/O-Lt. Sudhir Bishal of Vill+ PS-Bandwan, Dist-Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today in course of my Spl. mobile duty at Bandwan Bazar area at about 18:25 hrs received a credible source information over mobile, that one person namely Blue Bishal S/O-Lt. Sudhir Bishal of Vill+ PS-Bandwan, Dist-Purulia was selling Country sprit/ Foreign liquor in his Hotel i.e. Samir Hindu Hotel near Dr. A.N.Jha High School. Accordingly I, along with ASI Balaram Mahato and (1) C/600 Amit Shit (2) C/922 Sanjay Bauri both of Bandwan PS, Dist-Purulia vide Bandwan PS CC No. 788/21, Dtd-04/03/21 left for above noted place to work out the said source information. Then, at about 18:35 hrs we reached at said place and found the said persons are selling Foreign liquor in his Hotel i.e. Samir Hindu Hotel near Dr. A.N.Jha High School. So, with the help of accompanied force I searched thoroughly with proper decency and maintain all legal formalities and found that he was selling foreign liquor. Being asked he failed to produce any valid license or permission from concern authority to seal the following mention liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized (1) Officer Choice-08 bottles, containing 180ml. @ Rs. 140/- each (2) Mc Dowll's No. 1 RAM-53 bottles, containing 180ml. @ Rs. 153/- each (3) Imperial Blue-05 bottles, containing 180ml. @ Rs. 174/- each. One bottle of the each above mentioned items seized as sample file after preparing proper seizure list & labeling duly signed by the witnesses and accused persons.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Blue Bishal S/O-Lt. Sudhir Bishal of Vill+ PS-Bandwan, Dist-Purulia and arrange for its investigation.
