Sub: Complaint against Sankar Mahato (Male / 38 Yrs.) S/O- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla to start a specific case U/S- 46A(C) Bengal Excise Act.

Sir,

In producing here with one Sankar Mahato (Male / 38 Yrs) S/o- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla under arrest and seized articles one Plastic black colour container containing approx 27 (Twenty Seven) liters of ID liquors (MAHULA), on which 1 (one) liter as sample article under seizure as per enclosed seizure list.

I, SI Uttam Chatterjee of Barabazar PS do here by lodge this complaint as against Sankar Mahato (Male / 38 Yrs) S/o- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla that today (04.03.2021) during my duty received a source information that one person unauthorized carrying and selling ID liquor (MAHULA) at Vill - Tumrasole tola Bandhdih area under Barabazar P.S, Dist.- Purulla. I have been then verified the credibility of that information and immediately diarized the matter vide Barabazar PS GDE No 241 Dtd. 04.03.2021 at 17.15 hrs. As per direction of I.C Barabazar PS myself along with forces had been to Village- Tumrasole tola Bandhdih to work out the information. At about 18.05 hrs found one person moving at Tumrasole tola Bandhdih village area with one plastic container. We stopped him and on searching found one Plastic black colour container containing approx 27 (Twenty Seven) liters of ID liquors (MAHULA). On being asked he disclosed his identity as Sankar Mahato (Male / 38 Yrs) S/o- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla and failed to produced any supporting documents to carrying and selling the said articles i.e ID liquors (MAHULA). On being asked he confessed his guilt and stated that he selling the ID liquors (MAHULA) with intent to sell to make profit. He also admitted that he had no license or any authorization to carrying and selling. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the seized article in presence of witnesses and 1 liter ID liquors (MAHULA) taken as sample from that seizure as sample which was also duly labeled and also took signature of the accompanying witness on seizer list and label and the aforesaid accused person also. Thereafter, I secured arrest of the Accd. Sankar Mahato (Male / 38 Yrs) S/o- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla after preparing Memo of arrest & after observing all other formalities of arrest as per Cr.P.C and NHRC guide line, Informed him and his relatives regarding the ground of arrest. The arrest was made at 19.15 hrs.

Under the above circumstances I, therefore, pray before you that a specific case U/S- 46A(C) of Bengal Excise Act. may kindly be registered against said Sankar Mahato (Male / 38 Yrs) S/o- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla and also for arranging its investigation.
