Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulia under arrest and seized articles one Plastic black colour container containing approx 27 (Twenty Seven) liters of ID liquors (MAHULA), on which I (one) liter as sample article under seizure as per enclosed seizure list.

I, SI Uttam Chatterjee of Barabazar PS do here by lodge this complaint as against Sankar Mahato (Male / 38 Yrs) S/o- Late Padak Mahato of Village- Tumrasole tola Bandhdih, PS- Barabazar, Dist- Purulla that today (04.03,2021) during my duty received a source information that one person unauthorized carrying and selling ID liquor (MAHULA) at VIII. - Tumrasole tola Bandhdih area under Barabazar P.S, Dist.- Purulia, I have been then verified the credibility of that information and immediately diarized the matter vide Barabazar PS GDE Not 241 Dtd. 04.03.2021 at 17.15 hrs. As per direction of I.C Barabazar PS myself along with forces had been to Village- Tumrasole tola Bandhdih to work out the information. At about 18.05 hrs found one person moving at Turnrasole tola Bandhdih village area with one plastic container. We stopped him and on searching found one Plastic black colour container containing approx 27 (Twenty Seven) liters of ID liquors (MAHULA).
