Sir,

In producing here with one Ruku Mahato (42 Yrs) S/o- Kartik Mahato of Village- Damda, PS-Barabazar, Dist- Purulia under arrest and seized articles one Plastic Jerican containing approx 21 (Twenty One) liters of I.D liquors (MAHULA), on which 01 liter seized as sample under seizure list as per enclosed seizure list.

I, SI Uttam Chatterjee of Barabazar PS do here by lodge this complaint as against Ruku Mahato (42 Yrs) S/o- Kartik Mahato of Village- Damda, PS- Barabazar, Dist- Purulia that on 14.03.2021 during my mobile duty received a source information that one person unauthorized selling I.D liquor (MAHULA) at Village- Damda Aambagan bari near by the house of the accused person under Barabazar PS, Dist-Purulia. I have been then verified the credibility of that information and immediately diarized the matter vide Barabazar PS GDE No- 794 Dtd. 14.03.2021 at 15.45 hrs. As per direction of I.C Barabazar PS myself along with forces had been to Damda Aambagan bari near by the house of the accused person to work out the information. At about 16.45 hrs found one person was selling I.D liquor (MAHULA). When we reached Aambagan bari near by the house of the accused person, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Plastic Jerican containing approx 21 (Twenty One) liters of I.D liquors (MAHULA) for sale. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of I.D liquors. On being asked he confessed his guilt and stated that he selling the ID liquors (MAHULA) with intent to sell to make own profit. He disclosed his identity as Ruku Mahato (42 Yrs) S/o- Kartik Mahato of Village-Damda, PS- Barabazar, Dist- Purulia. He also admitted that he had no license or any authorization to carrying and selling. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the selzed article in presence of witnesses and 01 liter of I.D liquor (MAHULA) taken as sample from that seizure as sample which was also duly labeled and also took signature of the accompanying witness on seizer list and label as well as accused person also. Thereafter, I secured arrest of the accused Ruku Mahato (42 Yrs) S/o- Kartik Mahato of Village- Damda, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC quide line. Informed him and his relatives regarding the ground of arrest. The arrest was made at 18.05 hrs.
