In producing herewith one (01) arrested accd. person namely Achintya Bouri (27 yrs) S/O- Bhaju Bouri of Vill- Saldiha, PS- Hura, Dist- Purulia, along with seized 15 (Fifteen) sealed bottle of DIL SE (Country Spirit) containing each 600 ml and 15 (Fifteen) sealed bottle of DIL SE (Country Spirit) containing each 300 ml which was seized under proper seizure list.

I beg to submit that today i.e on 04.03.21 in between 19.05 hrs to 19.45 hrs during my patrolling duty acting on a source information myself along with force held raid in the house of Achintya Bouri S/O- Bhaju Bouri of Vill- Saldiha, PS- Hura, Dist- Purulia, against illegal stock and selling of liquor. During raid found that the above noted person was keeping/selling Country Spirit which was kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of liquor from his house. On asked he could not able to give any satisfactory answer for keeping and selling the same. Finding no other alternative I arrested him after observing all legal formalities and seized and labeled 15 (Fifteen) sealed bottle of DIL SE (Country Spirit) containing each 600 ml and 15 (Fifteen) sealed bottle of DIL SE (Country Spirit) containing each 300 ml which was seized under proper seizure list.

The above noted arrested accd. namely Achintya Bouri S/O- Bhaju Bouri of Vill- Saldiha, PS- Hura, Dist- Purulia has committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of country spirit from his house.

Under the fact and circumstances I pray before you that a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Achintya Bouri (27 yrs) S/O- Bhaju Bouri of Vill- Saldiha, PS- Hura, Dist- Purulia, and arrange for its investigation.
