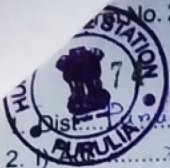


Sir,

In producing herewith the arrested accused Sarjen Mahato (24 yrs),S/O- Gurupada Mahato of vill- Madhuban, PS- Hura, Dist- Purulia and seized one iron made improvised firearm having length 9 inch approx from butt to barrel, having firing pin and trigger along with one (01) round 8mm ammunition. Today i.e on 08.03.2021 during night mobile duty at 22:05 hrs received credible source information that one person is moving suspiciously near Ladhurka morh possessing a gun with him. I informed the matter to O/C Hura PS and as per order I rushed to Ladhurka to work out the information. I ASI Sanat Chakraborty along with force reached at near Ladhurka morh at 22:25 hrs and kept the vehicle at a distance from the spot and then proceeded towards Ladhurka morh. We reached near Ladhurka morh and found that one person is going towards Ladhurka village from ladhurka morh. We apprehended him and on asked he disclosed his identity as Sarjen Mahato(24 yrs),S/O- Gurupada Mahato of vill- Madhuban, PS- Hura, Dist- Purulia. On search found that he possessed one iron made improvised country made firearm having length 9 inch approx from butt to barrel, having firing pin and trigger along with one (01) round 8mm ammunition is fitted in it. He possessed the said firearm at the left side of his waist. On asked he could not able to produce any licence or valid document in respect of possessing or carrying of that improvised fire arms. Finding no other alternative I arrested him after informing him the ground of arrest and after observing all legal formalities. I also seized the iron made improvised firearm with one (01) round ammunition from the exclusive possession of the arrested accused person Sarjen Mahato under proper seizure list in presence of witnesses duly signed by them.

Under the above circumstances I pray before you that a case may kindly be started under proper section of law against accused Sarjen Mahato (24 yrs),S/O- Gurupada Mahato of Vill- Madhuban, PS- Hura, Dist- Purulia for possessing and carrying of improvised country made fire arms illegally and arrange for its investigation.
