Sir,

In producing herewith one arrested Accd person namely Kalachand Mahato-32 years S/O Rasaraj Mahato of Village-Tilgora, PS-Para, Dist-Purulia and one seized tractor bearing registration No-WB-55A 2032 (Mahindra B 275 DI) with trolley loaded with approx 100 cft sand as per seizure list. I ASI Sk Monsur of Hura PS do hereby lodged a complaint against the owner and driver of the said seized tractor. The fact is that today i.e on 14/03/21 at 17:35 hrs while myself along with force were engaged in night mobile duty at PS area received a source information from my reliable source that one tractor with trolley mentioned above was coming from Ladhurka side towards Kalabani village having loaded with sand without any royalty/challan. I informed the matter to O/C Hura PS and as per direction I ASI Sk Monsur and force namely (1) C/580 Pradip Kr Bag (2) C/2808 Ujjwal Banerjee (3) HG/1781 Subhandu Sekhar Mahato rushed to work out the source information . When we reached at Belabahal more near Belabahal village at 17:55 hrs we found that one tractor with trolley coming towards Belabahal village. We intercept the tractor loaded with approx 100 Cft sand. On asked the driver of the tractor unable to produce the valid challan/ royalty in respect of the said sand as well as the tractor. So there is sufficient reason to belive that the owner and the driver of the said tractor stolen away sand from any river bed in a clandestine manner and they are involved in illegal business for wrongful gain. There is sufficient reasons to believe that the owner and driver of the said tractor is running clandestine business for gain with transportation of sand without any valid documents. Finding no other alternative I seized the tractor bearing registration No-WB-55A/2032(Mahindra B 275 DI) and trolley loaded with approx 100 Cft. sand after preparing proper seizure list duly signed by accompanied police persons because of unavailability of local people. On interrogation he disclosed his name and address which as noted above. Accordingly I arrested the Accd driver after observing all legal formalities.

Therefore I request that a specific case may kindly be registered against the owner and driver of the said seized tractor bearing Reg. No.- WB-55A/2032 under proper section of law and arrange for its investigation.
