Tudu along with force return to PS and brought under seizure 01(One) seized Mahindra B275DI Tractor with No plat showing WB55/TC 0013, Chasis No-Mahindra- 006516554B1-DS345C & Engine No- 006036847BADVA005, VAPL-I attached with a sand loaded trolley and lodged this complaint to the effect that on 04/03/2021, I along with force C/682- Mahadeb Rajak, C/696- Gorapada Pal, C/2705- Sanjay Kar & HG/1772- Fatik Ch. Kumar were performing evening mobile duty as per order vide Jhalda PS CC No- 625/2021, Dt- 04/03/2021. During evening mobile duty at about 19:45 hrs received a credible source information that some owners of the tractors were extracting sand illegally at Subarnarekha river near Shyamnagar Ghat. Accordingly, myself along with force left to work out the said source information.
