Sir,

I, SI- Bimal Kr. Tudu along with force return to PS and brought under seizure 01(One) seized Mahindra B275DI Tractor with No plat showing WB55/TC 0013, Chasis No- Mahindra- 006516554B1-DS345C & Engine No- 006036847BADVA005, VAPL-I attached with a sand loaded trolley and lodged this complaint to the effect that on 04/03/2021, I along with force C/682- Mahadeb Rajak, C/696- Gorapada Pal, C/2705- Sanjay Kar & HG/1772- Fatik Ch. Kumar were performing evening mobile duty as per order vide Jhalda PS CC No- 625/2021, Dt- 04/03/2021. During evening mobile duty at about 19:45 hrs received a credible source information that some owners of the tractors were extracting sand illegally at Subarnarekha river near Shyamnagar Ghat. Accordingly, myself along with force left to work out the said source information. Then, we intercept the aforesaid vehicle at Gokulnagar near Mahato hotel on Jhalda Baghmundi Road under Jhalda PS at about 20:15 hrs and found the above noted tractor was tagged with a trolley loaded with sand. But seeing the Police Party driver of Tractor and others fled away leaving his Tractor with sand loaded trolley on road. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. So there is every ground to reason to believe that the owner, driver and others of above noted Tractor dealing in sand business in clandestine manner and they do not have any proper challan or any documents related to the said loaded sand of above detained Tractor. So I, seized above noted Tractor with No plat showing WB55/TC 0013, Chasis No- Mahindra- 006516554B1-DS345C & Engine No- 006036847BADVA005, VAPL-I with attached sand loaded Trolley (approx 100 cft).

On return to Jhalda P.S., kept the aforesaid sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Owner and Driver of the Tractor with No plat showing WB55/TC 0013, Chasis No. Mahindra- 006516554B1-DS345C & Engine No- 006036847BADVA005, VAPL-I & others under proper section of law.
