In producing herewith the following arrested local persons (i) Tinku Kumar Das (39) SDU L. Subedar
Bn of Arambaghian Razakar, Ward No- II, PS-Jhajjar, Dist- Purulia (ii) SK. Shejod (21) SDU Sc. Subir Ali
of VII- Battalion, PS- Purulia (iii) SK- Andia & (iii) Ramkhan-Tarubhi (2) SDU Lechand Lashai of
VII- Battalion, PS- Andia, Dist- Purulia and brought under witness the following articles-(1) One Iron
country made Improvised pipe gun loaded approx. 10" including bat, loaded with one live .303 cartridge.
(2) One Iron made "Bhujia" with wooden Bat, Total Length approx. 1.7' (3) One Iron Rod Length about
2'5" break 2 cm. approx after preparing a scissor it's duly signed by the witnesses as well as acced.
persons. I do hereby lodge a written complaint against the above noted local persons and others in
effect that on 04/01/2021 at 2300 hrs received a telegraphic information from my source that Jhajjar area
located by the South West side of the Mayo Soberh of Jhajjar with a view to commit dacoity in the
Jhajjar Town Area. After getting such type of information I noted the fact in C.D. vide Jhajjar P.S. GDB
No. 169 Dt. 01/01/2021 and referred the matter to PC. Jhajjar P.S. and as per his direction myself along
with Const. 07386- Shreshtha Saha, O/SPI- MD, Heeb Khan, RGM 576- Harichand Ghosh and C773-
Samiul Moinab presented towards the Mayo Soberh of Jhajjar to work-out the said information with Const.
Vehicle No. WB90C 2741 with C.C. no. 55562. When myself along with accompanying force reached
near Saltash Police and stop the vehicle by the side of the road and proceeded to the Mayo Soberh on foot
and when we reached near the South West side of the Mayo Soberh on 05/01/2021 at 00.05 hrs and found
20 persons sitting by the side of a bush and whipping each and others. We tried to apprehend them but
among the police party they fled so flew away but in hot chase we able to apprehend the above noted three
local persons. On immediate search on their person One iron country made Improvised pipe gun loaded
with one live .303 cartridge from the right wrist under part of acced Tinku Kumar Das, One Iron country
made "Bhujia" with wooden Bat removed from SK. Shejod and One iron rod from the right hand grip
of acced. Ramkhan-Tarubhi On being asked they disclosed their identity as noted above and on
interrogation they disclosed that one SK. Kali of Karradih, PS-Jhajjar, Dist-Purulia and one SK. Majes
& Golam Sabir of Karradih, PS-Jhajjar, Dist-Purulia and two other persons who was unknown to them
was there but they fled away on getting the scint of police. On being asked they could not give any
satisfactory reason for keeping the pipe gun, Bhujia and other weapons to assemble the place at the dead
hour of night. On interrogation they also stated that they all assembled there to commit house dacoity in
the Jhajjar town area.

So, the three local persons were arrested after producing some memo and seized the all above
noted articles under prior seizure. It's duly signed by witnesses as well as the acced. persons. Due to odd
hours of night no public witness was available here.

So I therefore, lodged a complain against local persons namely (i) Tinku Kumar Das (39) SDU L.
Subedar Bn of Arambaghian Razakar, Ward No- II, PS- Jhajjar, Dist- Purulia (ii) SK. Shejod (21) SDU Sc.
Subir Ali of VII- Battalion, PS- Purulia (iii) Ramkhan-Tarubhi (2) SDU Lechand Lashai of
VII- Battalion, PS- Andia, Dist- Purulia (iv) SK. Kali of Karradih, PS- Jhajjar, Dist-Purulia and two others for committing the
offence U.P- 33B(1)(a) IPC & 25/27 Arms Act.
