In producing herewith the following arrested and, persons (i) Tinku Kumar Das (29) S/O Lt. Sriwant Das of Anandabhar, Itanagar, Ward No- 11, PS- Jhark, Dist- Purnia (ii) SK. Sheelaj (21) S/O Sr. Babu Ali of V.I.-Bhawan, PS- Purnia (iii) Dha- Purnia & (iv) Ramchitra Tarabhai (21) S/O Lalchand Tarabhai of V.I.-Bhawan, PS- Purnia (v) Dha- Purnia & (vi) Ramchitra Tarabhai (21) S/O Lalchand Tarabhai of V.I.-Bhawan, PS- Purnia (vii) SK. Raju of Karnataka, PS- Jhark, Dist- Purnia and brought under seizure the following articles- (i) One Iron Nail Length approx 10" with wooden Bar, Total Length approx 17" (ii) One Iron Nail Length approx 2 1/2" with wooden Bar, Total Length approx 17" (iii) One Iron Rod Length approx 2 1/2" head 2 cm. square after preparing a seizure list duly signed by the witnesses as well as each of the persons. I do hereby lodge a written complaint against the above noted and, persons and, others, to the effect that on 04/01/2021 at 23:00 hrs received a telephonic information from an source that 7-8 criminals are assembled by the South West side of the Mysa Sancher of Jhark with a view to commit dacoity in the Jhark Town Area. After getting such type of information I went the fact in C.I.D. vide Jhark P.S. GDE No- 109 Dt- 04/01/2021 and informed the matter to PC, Jhark P.S. and as per his direction myself along with three C7786- Sharda Kato, C6771- MJ. Prabh Chak, H64536- Hardeo Singh Chhuh and C7781- Sanjay Mishra proceeded towards the Mysa Sancher of Jhark to work upon the said information with Const. Vehicle No- WB30C 3701 vide C.C. no- 20627. When myself along with the accompanied force reached near Salazar Police and stop the vehicle by the side of the road and proceeded to the Mysa Sancher on foot and when we reached near the South West side of the Mysa Sancher on 05/01/21 at 00.05 hrs. and found 7-8 persons sitting by the side of a bush and whispering each and others. We tried to apprehend them but seeing the police party they tried to flee away but on hot chase we did not apprehend the above noted three and, persons. On immediate search on their person One Iron casing made improvised pipe gun loaded with one live 30S cartridge from the right waist under pass of and Tinku Kumar Das, One Iron casing made "Bhojai" with wooden Bar recovered from SK. Sheelaj and One Iron rod from the right hand grip of and, Ramchitra Tarabhai. On being asked they disclosed their identity as noted above and on interrogation they disclosed that one SK. Raju of Karnataka, PS- Jhark, Dist- Purnia and one SK. Mishra of Golden Sanch of Karnataka, PS- Jhark, Dist- Purnia and two other persons who was unknown to them was there but they fled away on getting the scent of police. On being asked they could not give any satisfactory reason for keeping the pipe gun, Bhojai and other weapons in assemblable place at the dead hour of night. On interrogation they also stated that they all assembled there to commit heave dacoity in the Jhark town area.

So, the three and, persons were arrested after preparing arrest memo and seized the all above noted articles under proper seizure list duly signed by witnesses as well as the and, persons. Due to odd hours of night no public witnesses are available here.
